## **Terms & Conditions**

#### Dear Customer:

Since the Inception of JS West, our credit policy has been one of accommodation for our many valued customers. Without whose past and continued business, friendship, confidence, and goodwill, we could not exist.

- 1. Our policy of "open account" credit for fuel, parts, and service is extended to qualified customers as a courtesy for our mutual convenience. To open an account, we require that all past and new customers complete a credit application. The applicant promises that any information provided on this credit application is true and complete. The applicant understands that this information is used to establish credit status by acknowledging that JS West has the right to investigate credit, employment, income records, and credit references. The applicant understands that we report the payment record to credit bureaus and other interested parties. A consumer report is obtained from a credit-reporting agency. The applicant may request a copy of this report and the name and information of the credit agency. Subsequent consumer reports may be requested or used with an update, renewal, or extension of credit.
- 2. A deposit may be required depending on the credit application. An account that is in good standing and kept current for one full year may have the deposit applied to the customer's account at their request. A credit card put on a statement balance may be accepted in lieu of deposit (with manager approval). If on a statement balance, your card will be charged automatically within two days after a statement is generated. Although your card is charged immediately you will still receive a statement via mail or email along with your receipt. If your card is rejected JS West will attempt to contact you to resolve the issues, however if it is rejected a second time the deposit will be required to continue service. If customer does not want to pay deposit or put a card on file, the customer will have "will-call COD" terms. If "will-call COD" the customer must pay for the fuel up front before delivery is made and follow the "will-call" terms. The conditions of being on "will-call" are as follows: customer is fully responsible for monitoring percentage in tank; when tank reaches approximately 30% customer must request a delivery; customer must order the minimum amount of fuel; estimated time of delivery can be up to two weeks; if customer requests driver to make a special trip, and diverts from their route, customer will be charged an additional fee, no exceptions. If a "will-call" account runs out of propane a mandatory pressure test must be completed and will result in an additional fee.
- 3. All credit approved customer will be on regular route, meaning the tank will be FILLED each time the driver is on that route. There are no additional fees to be on regular route.
- 4. Each fuel delivery will assess a fuel recovery fee.
- 5. If opening a location containing a "bulk" system, the new customer will be responsible for purchasing the fuel that is in the tank at the time of transfer.
- 6. A labor service/repair fee for pressure checks, appliance checks, lighting of pilots, or a transfer fee for new accounts (tanks or meters) may be assessed.
- 7. Any repair(s) needed will be billed out at an hourly rate. Repairs made outside of business hours are billed at an after-hours rate.
- 8. All tank rentals/leases are payable every 6 months in advance upon receipt of an invoice and will show as a **service fee** on the statement. An annual meter fee is applied to metered accounts (if applicable).
- 9. All purchases are due and payable 30 days from Invoice date. The applicant promises to pay for all purchases made on account, any finance charges, and other charges that may be assessed. Payments are not considered made or credited to the account until received by JS West. All balances not paid by the due date will be subject to a finance charge. Finance charges are computed by a periodic rate of 1.6% per month (19.2% APR). Finance charges are computed on adjusted balances. The applicant agrees to pay cost of collection, including reasonable attorney fees and cost incurred to effect collections, with or without suit, including preparation, filling, and foreclosure of any lien and all applicable late charges allowed by law.
- 10. If an account becomes thirty days past due, open account privileges may be rescinded. Gas service will be interrupted or terminated if an account continues in a past due status. In the event that should occur, there will be a reconnection fee.
- 11. When a customer moves or transfers service, JS West may opt to purchase propane back at a reduced rate. If a customer is to switch to a different propane provider, JS West will pick up leased equipment once notified. Customer owned tanks are ineligible for fuel refunds.
